ORDER DECLARING CANDIDATES ELECTED

WHEREAS, by order duly adopted by the Board of Directors (the "Board") of Fort Bend County Municipal Utility District No. 94, of Fort Bend County, Texas (the "District"), on February 2, 2022, a general election was called for the election of two (2) directors for the District, and for no other purpose, with such election to be held on May 7, 2022; and
