

**NOTICE OF CONSTITUTIONAL AMENDMENT AND
SPECIAL ELECTION

To the registered voters of the County of Fort Bend, Texas:
A los votantes registrados del Condado de Fort Bend, Texas:

Notice is hereby given that an election shall be held in the County on the 7th day of May, 2022, in which all resident, qualified electors of the County shall be entitled to vote for in a special election to adopt or reject the proposed Constitutional Amendments as submitted by the 87th Legislature, Third Called Session, of the State of Texas and for voters living within the territory of the proposed Fort Bend County Emergency Services District No. 9 to vote to approve, or disapprove, the creation of the proposed Emergency Services District No. 9 and the levy of a tax not to exceed Ten (10) cents on the one hundred (\$100.00) valuation. The polls shall be open for voting at such election from 7:00 a.m. to 7:00 p.m. Fort Bend County has adopted a countywide polling place program allowing voting at any election day polling location, and the election shall be conducted at each polling place, respectively, by the officers previously appointed by order of the Commissioners Court. The listing of polling places for May 7, 2022 is made a part hereof for all purposes.

Por la presente se notifica que se llevará a cabo una elección en el condado el 7 de mayo de 2022, en la que todos los electores calificados residentes del condado tendrán derecho a votar en una elección especial para adoptar o rechazar las enmiendas constitucionales propuestas. según lo presentado por la Legislatura 87, Tercera Sesión Convocada, del Estado de Texas y para los votantes que viven dentro del territorio del Distrito de Servicios de Emergencia No. 9 del Condado de Fort Bend propuesto para votar para aprobar o desaprobar la creación de los Servicios de Emergencia propuestos Distrito Núm. 9 y la imposición de un impuesto que no exceda de Diez (10) centavos sobre los cien (\$100.00) de valuación. Las urnas estarán abiertas para votar en dicha elección de 7:00 a. m. a 7:00 p. m. El condado de Fort Bend ha adoptado un programa de lugares de votación en todo el condado que permite votar en cualquier lugar de votación el día de las elecciones, y la elección se llevará a cabo en cada lugar de votación, respectivamente, por los funcionarios designados previamente por orden del Tribunal de Comisionados.
